Rule 16(c) reads as follows:

“(c) An employee, or his representative in behalf of the employee, will have sixty days from date his name first appears on the roster to appeal, in writing, his roster date or relative standing thereon, except that in case of a employee off duty on leave of absence, furlough, sickness, disability or suspension at the time the roster is posted, such time limit will apply from the date employee returns to duty. If no appeal is taken within the sixty day period, future appeals will not be entertained unless the employee’s roster date or his relative standing is changed from that first posted.”

Protest period expires April 30, 2024.

Therefore, all roster protests must be presented to the undersigned on or before April 30, 2024.
